1. Commercial Terms:

1.1 VISION INFOTECH INC is represented by "FREECASE " here & "Publisher Company name" is represented here by "The Publisher", The Publisher and FREECASE are collectively referred to as the "Parties" and individually as the "Party", as the case may be.

1.2 The distribution channels mentioned in this agreement are given below (The Publisher would direct the end user from this website to the product subdomains of FREECASE)

1.3 The Product subdomain as mentioned above, is where FREECASE is hosting the Product (legally licensed or developed content comprising all QUIZ content in FREECASE library).

1.4 FREECASE will share the revenue reports daily or as when requested by The Publisher through Google Manager/AdSense to track revenue and to maintain transparency.

1.5 The revenue share would be 80:20 wherein Publisher would get 80% of total revenue & FREECASE would get 20% of the total revenue. Total revenue is the revenue generated through Ad campaigns after reducing the fee charged by Ad Demand Partners/SSPs and deductions applicable if any as stated under clause 2.9 of section 2, on the Product assigned to The Publisher.

1.6 FREECASE will not charge any fee for Software/License/Service/Infrastructure costs & the entire product will remain free of cost for The Publisher. However, the Product remains the Intellectual Property of FREECASE . FREECASE is only licensing the Product to be published to use and promote till the time this agreement is in effect.

1.7 Either party may terminate this agreement at any time, with or without cause, and with no further financial obligation on the part of FREECASE (except payment for ads delivered up to the termination date) Upon expiration and/or early termination of this Agreement, all rights granted (as mentioned in clause 2.1) to The Publisher under this Agreement shall cease to exist.

2. Terms of the Agreement:

2.1 FREECASE hereby grants The Publisher, the worldwide, non-sublicensable, non-transferable, non- exclusive, and revocable rights to commercially use and promote, the Product (legally licensed or developed content comprising all QUIZ content in Client's library) by means of the Distribution Channels (as defined in point 1.2 of section 1).

2.2 The Publisher shall direct end users (an individual person or an entity who avails the Product or any value-added services involving the Product through a declared Distribution Channel) to the Product subdomain assigned to Publisher (as defined in point 1.2 of section 1).

2.3 The Publisher shall never attempt to host, copy, modify, re-format, resize, edit, alter, duplicate, port, create backups, store, remove FREECASE ' logo, reverse engineer, or re- engineer the Product, subdomain or any parts of the Product thereof.

2.4 Neither party for the purpose of usage or promotion of the Product will indulge in any activities which would go against any statutory law.

2.5 The Distribution Channel used to promote the Product shall not have any content which is obscene, defamatory, libelous, slanderous, violent, and/or unlawful. Further, there will be no software piracy, hacking, or illegal downloads of any kind.

2.6 The Publisher will not send any bot traffic (i.e. non-human traffic) on the Product or any of its subdomains using software, data centers or any other way. The Publisher will not cause any invalid activity on their distribution channel. The Publisher's account will be closely monitored for Invalid Activity.

Invalid Activity is any click on an ad or serving of an ad impression that may artificially inflate advertising revenue. It includes but is not limited to: (i) You indulging in clicking on ads or generation of impressions of ads manually; (ii) Repeated clicks on ads or repeated generation of impressions of ads by one or more of your users in an unnatural way or without genuine interest; (iii) You or your users using click-exchange or traffic- exchange programs, automated clicking tools or traffic sources, spam email marketing, robots, or other deceptive software; (iv) You encouraging clicks on ads from your users through request, instruction, inducement, deception, incentivization, etc.; (v) Use of the software by you or your users to change the location of your users (or geo- spoofing) to mislead us or our advertising partners into serving ads intended for another location; (vi) FREECASE ' product subdomains being made available to users whose browsers have JavaScript disabled or who are otherwise tampering with ad serving or measurement; (vii) You/The Publisher is sourcing users from products, whether own or third-party, that is or may reasonably be considered: illegal, unlawful, or infringing under any applicable laws; adult or pornographic; profane; promotional of drugs and drug paraphernalia; gambling-related; fake or deceptive; libelous; defamatory; invasive to privacy; or otherwise, suspicious in any manner; or (viii) Any other suspicious behavior or misconduct by you/The Publisher or your users.

2.7 The Publisher will not spam pages of social media channels or any digital product with links to product hosting sites, often accompanied with text or graphics that in no way represented content & is in violation of that social media or digital product policies.

2.8 The distribution channel cannot mislead the end user to promote the Product or any of its subdomains. Misleading the user means: misrepresenting, misstating, or concealing information about the Product, the purpose of the content, or the content itself from the end user. Misleading the users to content hosting

sites via means of obscene, pornographic, and unlawful content.

2.9 If any of the Ad demand partners/SSPs clients of FREECASE make revenue deductions on The Publisher's account, then FREECASE is entitled to deduct or ask back the deducted amount if already paid by sharing proper email/Screenshot proof and The Publisher agrees to accept deducted amount or pay back deductions as stated in the proof.

2.10 The Publisher agrees to be compliant with all the policies of Google that can be referred to by visiting this weblink [Google Policies](#).

2.11 If the product subdomain is found in any other place other than the declared distribution channel, or if the product subdomain is not found in the declared distribution channel even though the revenue was being generated, it would be a direct violation of the clause 2.2 of the agreement, which will then give FREECASE the right to withhold the payment of that product subdomain.

2.12 If the Publisher violates any terms of this agreement, FREECASE has the right to suspend the work & hold the payments for an indefinite period of time.

Confidentiality & Governance

The Publisher will hold this Agreement confidential and will not disclose the terms of this agreement to any other person/party without FREECASE's consent.

This Agreement shall be governed by and construed in accordance with the laws of the United States of America, without regard to its conflict of law principles. In the event of any dispute or legal proceeding, the exclusive jurisdiction shall be the federal or state courts located in Texas, USA.
